#### CONDITIONS FOR USE OF MARK

This document becomes a part of a legally enforceable agreement. By signing the contract a client deemed to have agreed to the terms and conditions mentioned below.

#### 1. Certification Conditions

#### 1.1 Introduction

The Client shall comply with the following conditions governing the use of the Certificate of Approval and mark/symbol of the DAS Pakistan.

## 1.2 Use of Certificate of Approval

- a. The certificate shall remain the property of the DAS Pakistan.
- b. Certificates are valid for three years from the date of the certificate issue, subject to satisfactory annual surveillance assessments.
- c. Certificates are not transferable.
- d. The certificate shall only be displayed at the location applicable to the certificated scope of supply.
- e. The certificate shall not be used to imply certification of any location other than that detailed on the certificate.
- f. The certificate shall not be used in any way to imply product approval.
- g. The certificated client must advise the DAS Pakistan of any changes which may affect the scope of supply.
- h. The certified client shall inform the DAS Pakistan, without delay, of matters that may affect the capability of the management system to continue to fulfil the requirements of the standard used for certification. These include, for example, changes relating to:
  - a. the legal, commercial, organisational status or ownership,
  - b. organisation and management (e.g. key managerial, decision-making or technical staff),
  - c. contact address and sites,
  - d. scope of operations under the certified management system, and
  - e. major changes to the management system and processes.
- i. <u>If the Client changes their operating site then the DAS Pakistan shall conduct a surveillance visit to check the relevant Management System is operating to the requirements of relevant standard</u>
- j. Mark for ISO 9001:2015 Accredited Mark (As Per Policy Doc.G-02/02 Issue Date:01/01/24 Rev No: 09) is used
- k. Mark for ISO 14001:2015 Accredited Mark (As Per Policy Doc.G-02/02 Issue Date:01/01/24 Rev No: 09) is used
- I. Mark for ISO 45001:2018 Accredited Mark (As Per Policy Doc.G-02/02 Issue Date:01/01/24 Rev No: 09) is used

### Example











- a. The mark above shall always be used on certificates issued in conjunction with the Client's name and have the certificate number adjacent to it.
- b. The mark may be used on stationery, such as headed letter paper and advertisin g brochures, and only in connection with the International achieve Standard scope of supply listed on the certificate.
- c. The mark shall not be used on flags, buildings, vehicles, packaging, directly on products, nor on promotional products such as calendars, diaries, coasters, etc.
- d. The mark shall not be used in any way to imply product approval, nor on documentation such as test certificates and certificates of conformity.
- e. The certificated Client shall, upon reasonable notice, discontinue any use of the mark which is considered to be unacceptable to the DAS Pakistan.
- f. The mark may be reproduced in any size provided the configuration is strictly adhered to, including the surrounding frame.

# 1.4 Use of the DAS Certification Unaccredited Logo







Note: The above logo shall be used if the client is certified to unaccredited ISO 9001:2015, 14001:2015 & 45001:2018

- Upon suspension of the accreditation, the certified body (The client) shall immediately cease to use its stationery and other publicity material that has the accreditation logo on it. The use can be restarted only after the suspension is revoked by the DAS.
- Upon termination of the certification the certified body (The client) shall immediately cease to use its stationery and other publicity material that has the certification logo on them

# Example

- a. The symbol shall never be used in conjunction with the accreditation body logo
- b. The symbol shall always be used in conjunction with the Client's name.
- c. The symbol may be used on stationery, such as headed letter paper, advertising brochures, test certificates and certificates of conformity and only in connection with the International Quality System Standard and scope of supply listed on the Certificate.
- d. The symbol may be used on vehicles, buildings or flags which bear the name or emblem of the Client.
- e. The symbol shall not be used in any way to imply product approval.
- f. The certified Client shall, upon reasonable notice, discontinue any use of the symbol which is considered to be unacceptable to the DAS Pakistan.
- g. Upon termination of the certification, for whatever reason, the Client shall discontinue all use of the symbol immediately.

The same conditions of logo usage shall apply in case of non-accredited certificates also.

# 1.5 Failure to Comply with the Certification Conditions Suspension and withdrawal of certificate approval

If the Client/certificate holder fails to maintain compliance with the requirements of certified standard such as ISO 9001, 14001, 45001 those requirements detailed in Certification Conditions Document and those commercial and operating requirements of the DAS Pakistan then;



- The client/certificate holder is formally informed in writing/fax/phone/email about the failure of compliance to the above conditions and asked to detail corrective action.
- If the client refuses to respond to correct the non-compliance to the above conditions then the DAS scheme manager shall contact the client and inform the client that the certificate may be suspended initially for 6 months and after 6 months if the situation is unchanged the certificate is cancelled and the client is required to return the certificate and cease to use and distribute any literature, stationery, etc., referencing the certificate of DAS Pakistan mark/symbol.
- If the period of surveillance exceeds the contracted period from completion of the stage 2 audit (6m, 9m, 12m.) or the recertification period exceeded the three year period the rules of suspension also apply

## **Special Audits**

- Extension to scope DAS shall review the application for extension to the scope of certification and shall determine the need of any audit activities. Depending on the complexity of there change this may require a special visit or may be conducted in conjunction with a surveillance audit.
- Reduction of scope of certification DAS shall review the extent of reduction of scope of certification and the Scheme Manager will determine the need of any audit activities. SNR shall contact the client and ask him to return the certificate and then re-issue a certificate with the reduced scope.
- Short-notice audits DAS reserve the right to conduct short notice audits on certified clients to investigate complaints, in response to changes or as follow up on suspended clients.
